# HISTORY & BACKGROUND

Established in 1901 in Hamburg, Schutzverein Deutscher Rheder V.a.G. (Schutzverein) assists its Members in Freight, Demurrage & Defence (FD&D) cases and provides insurance cover on a mutual basis.

The overwhelming majority of Schutzverein Members are Shipowners, but Charterers can also enter the Club. Since 2023 Shipmanagers can become Members as well - provided that the vessel has not already been registered by the Shipowner or Charterer.

# OUR EXPERTISE

Members are supported by a legally qualified and highly experienced team in Hamburg plus a worldwide network of correspondent agents and external lawyers handling several hundreds of cases and inquiries per year.

Schutzverein is actively involved in the development of standard contracts and clauses, especially for charterparties, and is a BIMCO member since 1932.





## COVER

Members are covered for legal expenses, i.e. court and arbitration costs as well as lawyers' fees in disputes relating to

- Charterparties
- Insurance contracts
- Marine fuel and lubricating oil purchase contracts
- Sale & purchase contracts
- Building contracts and repair contracts
- General Average adjustments
- Similar matters

For Manager Members cover extends to legal expenses relating to disputes under shipmanagement contracts.

The positive outcome of an FD&D dispute directly affects Members' financial position - Members will obtain funds or be in the position to avoid a payment.

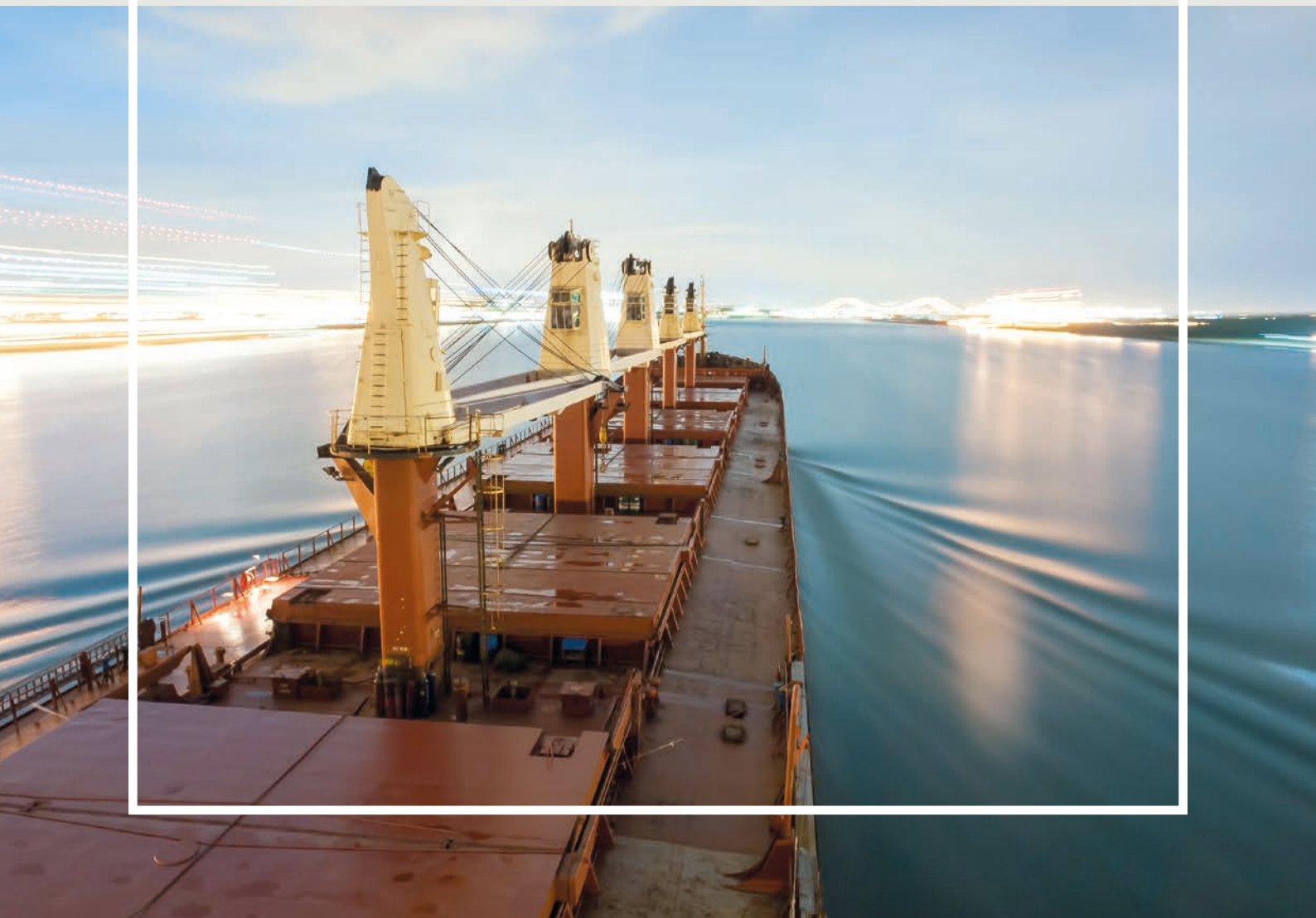
## FURTHER MEMBERSHIP BENEFITS

## EXAMPLE CASES

- **TIME CHARTERPARTIES** - e.g. cases concerning non-payment of hire/deductions from hire, responsibility for time losses (off-hire), damage to the vessel, bunkers, etc.
- **VOYAGE CHARTERPARTIES** - e.g. disputes about freight payment, the exercise of a lien, demurrage with the Club being involved on Owners' side in cases like The "Ladytramp" (judgement of the English Court of Appeal on laytime counting under a Sugar Charter Party 1999 form) and The "Amalie Essberger" (High Court proceedings on time bar issues concerning a demurrage claim under an Asbatankvoy form)
- **BUNKER SUPPLY CONTRACTS** - bunker quantity and quality as well as practical issues (e.g. on the sampling procedure)
- **INSURANCE CONTRACTS** - mainly cases concerning cover under Hull & Machinery, Protection & Indemnity or Loss of Hire policies
